

K-rules at the Department of Political Science: obligations and compensation rules in the field of education and supervision

Obligations:

Professors and associate professors	9 K/year (newly hired associate professors are given 4K in advance)
Postdocs	2 K/year (9 K department-funded)
Assistant professors	15 K for 3-year assistant professorships 20 K for 4-year department-funded assistant professorships 17 K for 4-year project-funded (3+1) assistant professorships
PhD students	Two courses, cf. note on PhD teaching

Chair, assessment of doctoral dissertations	1 K

Other tasks:

Buyout	K-compensation is effected as implementation of the budget underlying the grant received
Sabbatical research semester	Every 13th semester of employment after the PhD is a sabbatical research semester. You earn 4.5 K for each 13th semester of employment (and still during buyout).
Learn Danish	Non-Danish-speaking assistant professors, associate professors and professors are compensated with 2 K for completing the Danish course “Lær dansk”, level 3, or a course at a similar level. To receive compensation, present your course diploma to the head of secretariat.
Senior staff scheme	Voluntary retirement package compensated with up to 4 K by agreement
Sickness	For professors and associate professors with permanent contract, consecutive periods of illness lasting more than 14 days are compensated proportionately. For example, 2 months of illness: $((9K/12)*2 \text{ months} = 1.5K)$. PhD students follow the rules of contract extension managed by the PhD school. For post docs and assistant professors without a permanent contract different models may be arranged with Head of Department and project owner.
Parental leave	<p>Professors and associate professors with a permanent contract and a K-obligation of 9K/year: Leave periods longer than 2 months (in total) are compensated with the normal K obligation in the leave period plus a K bonus equal to 0.5 times this obligation. 6 months of leave are thus compensated with 6.75K.</p> <p>-</p> <p>Assistant professors and postdocs without a permanent contract will typically have their contracts extended with the length of their leave. The HR department can inform about the exact conditions. In addition, the department provides a K bonus for leave periods longer than two months (in total) equal to 0.5 times the leave period. For assistant professors with a K-norm of 5K/year, 6 months of leave will be compensated with 1.25K. For postdocs with a teaching norm of 2K/year, 6 months of leave will be compensated with 0.5K. Postdocs may request to have their contract extended instead. 6 months of leave will lead to 20 days</p>

extension. Assistant professors may only in exceptional cases have their contracts extended instead.

PhD-students can have their contracts extended according to the rules of the PhD-school.

K-standards for supervision:

PhD supervision	Compensation for PhD supervision gives 2 K to the main supervisor and 1 K to any co-supervisor. K for PhD supervision is awarded the year in which the defense takes place. If the doctoral program is completed without a defense, a special agreement must be made regarding the amount of K compensation
Thesis supervision	0.25 K for 1 student, increases by 50% per extra student Each employee can be credited for max. 12 theses per year, measured as a running average over a three-year period. For theses submitted as part of a 4+4 PhD program, 0.25 K are split evenly between main and co-supervisor. Co-supervisor in Politics and Economics receives 0.15 K Thesis preparation supervisor (International Studies): 0.04K
Bachelor supervision	Co-supervisor on bachelor projects in Politics and Economics receives 0.15 K Supervisor on bachelor project in Public Health Science receives 0.2 K (not when part of BA seminar)
Internships (Pol/Econ)	Supervisor on 20 ECTS internship paper: 0.15 K Supervisor on 10 ECTS internship paper: 0.10 K
Internships (International Studies)	Supervisor on 30 ECTS internship paper: 0.15 K

K-standards for teaching:

In general: K for lectures, coordination and exams handled by several teachers is distributed proportionally.

Doubled FMOL courses	50% extra K for each class
MA thesis supervision	0.25 K
Subject coordination for inter-institutional subjects	0.25 K

In very special cases, K can be paid as a one-off payment by agreement with the head of department. In that case, 1k corresponds to DKK 50,000.
